

The invoice amount is an astonishing \$16,428.40. This amount is paid once a month, every month. Each time, this sum is no longer available to support USM academic programs, or USM faculty members.

At \$16,428.40, we're talking about *not supporting* two USM faculty who are earning about \$65,000 each. This amount could also support three USM faculty who are each earning \$40,000 per year. Of course, these five hypothetical faculty are 9-month USM employees. The lease payment is due *every* month, not just those from August through May.

The USM family needs to think about this situation, every time Saunders' name comes up, or whenever she delivers a commencement address or convocation speech. If wallet-size copies of this voucher could be put into the hands of each USM faculty and staff member, that would also be a good thing. Having something to pull out and gaze at every time a new program cut, or faculty elimination, comes down from the dome, would indeed be welcomed.



One wonders how long USM can remain afloat with expenditures like these. USM is, and will be, saddled with this plane lease for months and months to come. Nothing about it is central to educational mission of the institution. In an era when teetering financial institutions and other private business entities are castigated by members of the U.S. Congress for maintaining company aircraft, how USM is able to pull one over on Mississippi taxpayers simply boggles the mind.
